DFWMGRC BOARD OF DIRECTORS MEETING
October 26, 2004

Meeting was called to order at 7:05 p.m.

Reading of previous minutes was waived since they were distributed to the board via email.

Recording Secretary Received application for new membership from Carol & Richard Gilbert from England. They have been heavily involved in Goldens and PBGVs in England. The husband judged PBGVs at Crufts.

Treasurer's Report: Ann Horton turned in receipts for the 2004 Hunt test last April: \$1,419 expenses. This gave us a profit of \$748.56 from the hunt test, and \$490.93 for the WC/WCX. Our current balance is \$14,024. Roger Long performed the third quarter financial audit. The 3rd quarter financial statement was distributed for review as well as a current financial statement.

COMMITTEE REPORTS:

Nominating Committee: Information for slate of officers is in the October newsletter. We will take nominations from the floor at the November meeting. Officers will be elected in January.

UNFINISHED BUSINESS:

Hunt Test and WC/WCX for 2005

Roger reported that the field committee met and suggested that Roger check on the eligibility and availability of the following judges:

SH JC Parks and whoever he wants to work with
JH Bill Teague, Dean Steinberg. Roger mentioned that Dean Steinberg is not an approved judge. Rita mentioned that he has recently judged an event
WC/WCX: Doug McGuire, Roger Thurman, and Terry Jacobs

The Board disapproved of JC Parks choosing who he wants to work with, and said that the committee needs to choose the judge. It was also mentioned that JC Parks has been on suspension and it was questioned if he would pull an entry.

It was mentioned that Terry Jacobs had judged several years ago and had many complaints about her moving the bird after the drop.

A discussion ensued regarding the method for selecting judges for the hunt test. Roger said the field committee is adamant that the rules say the field committee has the final say on the judges. Judy and Rita said that since the membership can override any of the rules or committee decisions, that the final vote on the judges lies with the membership. This will be a topic brought up to the membership at the next meeting.

There was also a discussion about the date of the hunt test, since it was moved last year without membership or board approval. If the date of the hunt test is going to be moved, it has to be by membership vote.

2005 Specialty and Obedience Trial

Sherri reported that we can use a room in the main building at the show site for the judge's dinner. The cost will be \$300 to rent the room, plus we have to use an approved caterer. Sherri has a list of the approved caterers. Alan suggested that we charge enough for the dinner to cover the cost of the room. Sherri reported that Purina is now sponsoring the specialty shows, and our ring fee will be reduced by \$150. Judy mentioned speaking with Ida Morino to see if she will cover the additional \$150. This will be discussed at the membership meeting in November and Sherri will turn it over to Holly Reagan, who will be doing hospitality again.

Judy asked Donna where the wicket is. Donna said she has it, but will get it to Lynda Williams, the bench chair, as soon as she can.

IRS tax question: Rita asked whether or not Kate had submitted her promised report on the entire incident. Judy said she has not received it.

NEW BUSINESS:

Ad in National Catalog:

Judy said she received word from the National Specialty committee that several ads were lost on the way to the printer – ours being one of them. The National Specialty committee apologized profusely and said they will place the ad on the GRCA web page for a period of time and will refund our money. **A motion was made and seconded** to donate the \$45 cost of the ad back to the Local Organizing Committee to help with cost overruns. The motion carried unanimously.

Show Dog Hall of Fame Trophy

Judy has received a request from Kendra Johnson to have her dog, Andre, listed on the Show Dog Hall of Fame trophy this year even though she has not attended the requisite meetings. Judy said the membership has the right to override any of the standing rules. Sherri mentioned that the standing rules might not actually cover this trophy because the rules state that in order to “win” a trophy, the member has to attend 4 meetings or work 2 events. Sherri also said that the description of the trophy says that it “honors” all Golden Retrievers who earn this award. Since the dogs don’t “win” the trophy to the exclusion of others, the rules would not apply here. There was a lengthy discussion with the decision being that it will be brought to the membership at the November meeting. If the membership votes to add Andre’s name to the trophy, we will also present adding dogs in the past whose names were not included on the trophy.

2004 Good Sportsmanship Award: Need a reminder in newsletter for members to make nominations. We will discuss it at the next membership meeting.

GR Foundation Videotape:

Judy said the Foundation is going to distribute their new videotape to all the member clubs (Donna Gulledge). She thought it would be good to show at the November membership meeting.

Standing Rules:

Judy brought up several standing rules that should be reviewed and submitted to the bylaws committee for revision:

Page 6, Eligibility for Board of Directors – suggests changing “one person per family” to “one person per household.”

Page 12, III – Recommend a committee chairman must attend a minimum of one meeting per year.

Recommend that Performance event committees are **recommended** to meet a minimum of two times annually and sponsor one non-regular event (fun match, training day, seminar, etc.)

Page 13, 14 – Responsibilities of Performance Event – should these be deleted? Judy recommends that if we are going to follow the bylaws, then we need to take out areas that have not historically been followed.

Page 16 – Guidelines for Selecting Judges for Licensed Events – Suggest we change the notification of judges names in the newsletter from two months to one month. This section might need to be completely reworked to reflect nominations from the floor at a membership meeting.

Page 24 – Standing Rules and Trophies and Awards – This should be reviewed and possibly changed to reflect that the dynamics of showing has changed.

Page 25 – Continue standing rules and trophies and awards – Section D – This section should be reviewed to allow for long-standing, active members to be considered even if meeting requirements are not met. We need to take a “kinder, more gentle” approach to how our members are treated and rewarded. Also proposed that any member in good standing (i.e., paid up on dues) should be able to receive a plaque and/or “honorary” award.

New Members – Give permission to the board to vote in new members who have attended the requisite number of meetings, but no quorum was present at the meetings.

Trophies not awarded – Look at the possibility of opening up the trophies to include **all** members if no one who has met the meeting requirements has applied for the trophy.

A motion to adjourn was made. Meeting adjourned.
