In Arlington, take the GreenOaks/Little Rd exit. Proceed thru the first stop light at bottom of ramp and remain on access road. At Second stoplight, Little Rd, turn Left or South. Proceed under I20 south, under another bridge of 287 into Kennedale.

Once under that bridge entering Kennedale, BE SURE TO DRIVE THE EXACT SPEED LIMIT....

Go into Kennedale, past the first stoplight at the Diamond Shamrock on right. Follow Little Road south into an S curve. after the curve, turn Right on Shady Creek. This is the entrance to the neighborhood and there is a red brick entry way wall. Follow Shady creek to the first street you can turn Right on, Oak Ridge Trail. Follow it past the curve to the left and up the hill. At top of hill turn Right on Meadowlake Crt. Pet Poison Safety: Products Sweetened with Xylitol Can Be Toxic To Dogs

The ASPCA Animal Poison Control Center (APCC) has issued a warning to pet owners that xylitol, a sweetener found in many sugar-free products, can cause serious problems for companion canines.

"Last year, we managed more than 170 cases involving xylitol," says the APCC's Dana Farbman, CVT. "This is a significant increase from 2004, when we managed about 70." And in the first half of 2006, toxicologists have already handled 114 cases. "It's difficult to say why there's such an increase," says Farbman. "Xylitol products are relatively new to the United States marketplace, so one possibility may be an increase in availability."

Dogs ingesting significant amounts of items sweetened with xylitol could develop a fairly sudden drop in blood sugar, resulting in depression, loss of coordination and seizures. Signs can develop quite rapidly, sometimes less than half an hour after ingestion.

It was previously thought that only large concentrations of xylitol resulted in problems—but new data is beginning to disprove this. "We seem to be learning new information with each case we manage," says APCC veterinary toxicologist Dr. Eric Dunayer. "We also have begun to see problems developing from ingestions of products with lesser amounts of this sweetener." APCC experts urge pet owners to keep candy, gum and other foods containing xylitol out of their animals' reach. If you suspect that your pet has ingested products sweetened with xylitol or any other potentially dangerous substance call your veterinarian or the APCC's emergency hotline at (888) 426-4435 for round-the-clock telephone assistance. SEPTEMBER BOARD MINUTES

A board meeting was held at the home of the President on Aug 7 2006

Apologies were received from Judy Word, and from Debbie Allan All other Board members were present. Brooke Annis has offeried her resignation from the DFWMGRC. The reasons for this were the subject of further discussion. It was generally agreed that ways should be sought to reunite the club and end the perpetual Saber Rattling that was affecting club morale.

The next membership meeting topic will be the National.

A motion that Stacey Blair should be offered Honorary Membership status was carried unanimously. Rita presented the Treasurers Report which was accepted. DFWMGRC STATEMENT

October 25th 2006

As you may have heard through the grapevine, our Club is being sued.

On October 13th, the DFWMGRC was served with a lawsuit filed by Ellen and Alan Meyer who are current members of the DFWMGRC. Due to the sensitive nature of this matter, and because this is, an active lawsuit, we have prepared this written statement. We want to keep the membership informed, but we don't want to jeopardize our legal position in this matter. We want all the members to know that we will do what we believe is in the best interest of the membership and our Club. We are prepared to take whatever steps are necessary to protect the integrity of our Club and its members.

Until papers were served, the Board was bound by the Confidentiality Clause in our Club's rules, so we were unable to discuss any of the details of the incident with the membership. However, the Petition is now public record and we are able to give you a background synopsis.

Briefly:

In 2005 a member of our Club filed a complaint with the Board against Alan and Ellen. In accordance with our Rules, the 2005 Board held a hearing and the member's complaint was upheld. As the complaint was based on misuse of the puppy referral service, the sanctions levied by the Board were to withdraw the privilege of use of this service from the Meyers for a finite period of time.

During this year, the 2006 Board has continued to enforce the sanctions as imposed by the previous Board. There have been no further hearings or charges during this period.

It appears the Meyers feel the withdrawal of this privilege is restricting their ability to trade and have decided to sue our Club. In their petition, they claim breach of contract, negligence and gross negligence, negligent misrepresentation, civil conspiracy, breach of the Texas Free Enterprise and Antitrust Laws of 1983, breach of fiduciary duty, and tortious interference. They are seeking an unspecified amount of economic damages, incidental damages, punitive damages, attorney fees and costs of court. They are also seeking treble damages for breach of the antitrust statutes. Our attorneys believe the claims are totally without merit.

Robert L. Galloway and Jack Balderson of Thompson and Knight have readily agreed to represent our Club pro bono. The only cost to our Club will be out of pocket expenses and court costs, if any. Thompson and Knight is among the top 10 law firms in the USA and both Mr. Galloway and Mr. Balderson are partners in that prestigious firm

Our attorneys will be filing a response on behalf of DFWMGRC with discovery requests shortly and at that time a copy of the pleadings and an explanatory letter from the Board will be made available to the membership.

Your Board believes when you have reviewed all of the facts presented, you will reach the same conclusion as the Board; that is to vigorously defend and protect our Club, the DFWMGRC.
