Dear Delegate:

AKC President Dennis Sprung announced at the December meeting that AKC would seek the input of Delegates on the subject of the possibility of permitting limited mixed breed dog participation in AKC programs. Specifically, AKC Staff is researching a listing service for spayed and neutered mixed breed dogs which would allow them to compete in AKC Companion Events (agility, obedience, rally, and tracking).

We want to give the Fancy ample opportunity to give feedback before proceeding with forming any program proposals. We request that you respond to the Mixed Breed Dog Participation Survey so we can receive your opinions on the subject. Staff also has prepared an informational packet that contains background and facts regarding mixed breed dogs and

**DOGGIE BIRTHDAY CAKE**

1 1/2 cups flour  
 1 1/2 tsp. baking powder  
 1/2 cup soft butter  
 1/2 cup corn oil  
 1 jar of baby food, meat, beef, strained (jar is tiny one is enough)  
 4 eggs  
 2 strips beef jerky

Preheat oven to 325 degrees. Grease and flour a loaf pan. Cream butter til smooth. Add corn oil, baby food and eggs. Mix til smooth.  
 Mix dry ingredients til batter is smooth. Crumble beef jerky and fold into batter. Pour batter into loaf pan. Bake 1 hour and 10 minutes. Cool on wire rack 15 minutes. Ice with plain yogurt or cottage cheese.
