How to Give Canine CPR By Lori S. Mohr (as referenced by First Aid For Dogs by Tim Hawcroft)

CPR (cardiopulmonary resuscitation) is the process of breathing life back into an unconscious human. A similar technique can also work effectively on dogs.

The signs that indicate the need for CPR include unconsciousness, lack of arousal, lack of physical movement, or eye blinking. These symptoms can occur from drowning, choking, electrical shock, or a number of other situations. The key to canine CPR is remembering the ABCs:

Airway,

Breathing, and

Cardiac compression.

To perform the three techniques, follow these steps. http://www.billfoundation.org/news/cpr1.jpg>

- 1. Lay the dog on a flat surface on its right side and extend the head back to create an airway.
- 2. Open the jaws to check for obstructions, and if any exist and are not easily removed, do one of two things, depending on the size of the dog.
 - * For small dogs, hold them upside down by their back end and shake vigorously to try removing the obstruction.
 - * For large dogs, lay them on their side and, if necessary, use long-nosed pliers to remove the obstruction.
- 3. Cup your hands around the muzzle of the dog's mouth so that only the nostrils are clear. Blow air into the nostrils with five or six quick breaths, again, depending on the size of the dog. Continue the quick breaths at a rate of one breath every three seconds or 20 breaths per minute.
 - * Small dogs and puppies require short and shallow breaths.
 - * Large dogs need longer and deeper breaths.
- 4. Check for a heartbeat by using your finger on the inside of the thigh, just above the knee.

If you don't feel a pulse, put your hand over the dog's chest cavity where the elbow touches the middle of the chest. If you still don't find a pulse, have one person continue breathing into the nostrils (mouth to snout), while another gives cardiac massage.

Give the dog a cardiac massage by placing both hands palms down between the third and sixth rib on the chest cavity.

- * For small dogs or puppies, place one hand or thumb on the chest.
- * For large dogs, place your hands on top of each other.

Use the heel of your hand(s) to push down for 10 quick compressions and then check to see if consciousness has been restored.

If consciousness has not been restored, continue the compressions in cycles of about 10 every six seconds for 10 cycles a minute.

After each cycle of compression, the other person should give the dog two breaths of air in the nostrils. If only one person is present, this procedure can still be done successfully.

5. Once the dog has started breathing, contact a veterinarian immediately.

Minutes of the Membership Meeting July 1, 2009

The meeting was held at Linda Miller's house. Donna Todd, President, called the meeting to order at 7:10 pm.

Twenty-three members were present. A guorum was established. There were 4 visitors present:

Gil & Trish Sloan – first visit since submission of their membership application:

Teresa McKenna – 2nd visit after submission of her application Nathan Risinger – 1st visit, but has not submitted his membership application yet

Donna reported that since JJ Allen, Recording Secretary, is absent, Sherri Farmer will take minutes. JJ did not submit minutes from the previous meeting, so no minutes were read.

OFFICERS REPORTS:

President – No report

Vice President – Kathy Felix is absent – no report

Corresponding Secretary – Patti introduced the visitors present (as noted above). Patti also announced that DFWMGRR is hosting a pizza night benefiting rescue on July 13 at the California Pizza Kitchen in Preston Center and asked everyone to participate if possible. A portion of all sales will go to rescue.

Treasurer – Lesley reported on the balance in the savings and checking accounts.

Recording Secretary – JJ Allen is absent – no report

COMMITTEE REPORTS:

2009 Specialty Committee: Patti reported the following profits from the specialty weekend:

Specialty profit: \$ 701.51

Raffle: 942.00 Silent Auction: 2,175.00 Eve Clinic: 1.640.00

Heart Clinic: 2,999.67 (including the Doppler Clinic)

Total Profit for the Weekend: \$8,458.18

Patti also announced that we need a show chair for the 2010 specialty.

David Brown reported that he attended the Texas Combined Specialty Meeting. They have new officers, but the treasurer was not replaced. It is possible that we could have a problem getting funds from them next year, like we had this year. He said that there's another meeting in August. Our application to host the specialty has to be submitted to AKC in September. Our application to FWKC to be a part of the combined specialty is due July 20.

2009 Agility Trial: Sherri reported that everything is in order. She asked for volunteers and announced when the trailer would be unloaded on Friday and when it will need to be reloaded on Sunday afternoon. Barbara Brown and Patti Caldwell volunteered to man the raffle table. A few people volunteered to work during the trial. Sherri said she would turn the information over to Shari Degan, Chief Ring Steward, and Kathy Felix regarding the raffle.

Nominating Committee: Donna announced that Molly Chapman is chairman of the Nominating Committee, and asked anyone who is interested in running for a position on the board to contact Molly.

OLD BUSINESS:

No old business from previous membership meetings was presented.

NEW BUSINESS:

Donna announced that Judy Word had suggested earlier that Claire Firestone be voted in as an honorary club member. Clair is moving to Connecticut and it was discussed that for as long as Claire has been a club member and for all she has done for the club over the years, that it was befitting that she be made an honorary club member. Judy Word made a motion for same; Sherri Farmer seconded. Claire was elected as an honorary club member by a unanimous vote of the members present.

Patti mentioned that September 1 is the deadline for the club and individuals to send in an ad for the National Specialty catalog. The ads are \$130 for a full page. Sherri Farmer made a motion for the club to place a full-page ad; Patti seconded. During the discussion, David Brown said he thought he remembered years ago that the club voted to place an ad in every national catalog. Several long-time members agreed. Nevertheless, a vote was taken on the motion. Motion carried unanimously.

Patti said that the National Specialty in 2010 is in Colorado and the Mi-Hi club is doing a photo contest as a fund raiser. She said she will send the information to Janet to put in the next newsletter.

Rule Change: Donna presented a rule change that was in the last newsletter. Apparently in December 2007 when the massive rule changes were made, there was a question as to whether Article III, Section 1 was supposed to be changed to state that the newsletter shall be "sent" to the membership, as opposed to being "mailed by first class mail." In order to be sure the club is following the membership's wishes concerning distribution of the newsletter, the Board presented a formal rule change, as presented in the July 2009 newsletter to change Article III, Section 1 as follows: "Written notice of each meeting shall be given in the official publications of the Club or by the Corresponding Secretary and shall be [mailed first class and postmarked] sent at least ten (10) days prior to the date of the meeting." (Remove the language "mailed first class and postmarked" and replace it with the word "sent.") Rita Robins made a motion that this be sent to the Bylaws Committee to be presented to the membership at a later date. Stephanie Longinotti seconded the motion. It was discussed that the Board has the authority to present rule changes to the membership. It was also discussed that sending it to the Bylaws Committee was only delaying the membership the right to vote on it and the delay was unnecessary. Motion to send the proposed rule change to the Bylaws committee failed on a vote. Donna Gulledge brought up a typo in the proposed rule change and everyone agreed that it should be corrected by adding the word "be" in the newly revised rule. Everyone agreed that it was a housekeeping issue and would be corrected. John Frick made a motion to accept the rule change as presented in the newsletter, with the housekeeping change. The motion was seconded and passed with 19 votes for, and 4 abstentions. No votes were made in opposition to the rule change.

Rita then brought up that the board had, in a previous board meeting, passed a policy that any members who want to receive the newsletter via US mail would have to pay \$24 per year. Rita mentioned that the Club Rules Pertaining to Club Publications provide that non-members who wish to subscribe to the newsletter must pay \$12 per year. It was agreed by the board members present to rescind their policy of \$24 and that the Bylaws Committee can discuss the dollar amount for anyone who wants to receive the newsletter by US Mail. Janet said that she has not had anyone, member or non-member, request the newsletter via US Mail.

Note: It was requested that only people who participate in obedience vote for the judge.

Janet said she would notify Shari Degan to contact Helen Smith to see if she's available to judge.

Sweepstakes Judge:

Maura Phelan (Austin, Texas) (Long-time breeder – Happy Hour Goldens; going for her judges license; doesn't have many show dogs in this area, so shouldn't be a conflict with anyone.)

Donna Ernst (Ohio) (Breeder for 20 years – Anthem Goldens; trying to get licensed as a judge; needs the assignment, will pay all her own expenses and not charge a fee.)

John Studebaker (Michigan) – Mentioned that he is trying to get his judging license in sporting breeds and he needs the assignment. He is already on the panel for the weekend, so expenses would be nominal.
