## DFWMGRC MEMBERSHIP MEETING

Online via GoToMeeting, Wednesday, 1/20/21

This was another teleconference meeting due to the covid restrictions.

A quorum was present.

Meeting started at 7:00 p.m.

Reading of minutes from December 20<sup>th</sup> meeting was waived.

President, Lesley Pettengill, informed the members that our Newsletter editor, Janet Frick, who has done a fantastic job for over 20 years, has decided to step down. She asked if anyone was interested in taking her place, with no response. She mentioned that the Board had wondered if we still need a newsletter since social media and our corresponding secretary do a good job of keeping club members informed of upcoming events, etc. After some discussion, it was determined that we do want to continue with the Newsletter, so we will look for a new editor.

Shari Degan reported on Agility Trial: Profit for the November Agility Trial was \$3856.02. This combined with the regular February trial made a huge impact on the Club's ending the year with a profit.

Carol Sandusky gave Treasurer's Report: Our December Specialty made a profit of \$318.11. The December WC/WCX made \$476.67. And as Shari mentioned, the November Trial had a profit of \$3856.02. End of Year profit was \$2,309,.88.

### COMMITTEE REPORTS

David and Barbara Brown-Bench: Our March Specialty is Friday, the 26<sup>th</sup> in Fort Worth. Onofrio is the Superintendent. Patti Caldwell is Chairman. Sweeps judge is Kemah Plusk. Regular judge is Ted Eubank. Obedience judge is Christopher Cornell. Rally is Cathleen Cabellero. Dick Caldwell and Patrick Harden are our stewards. Donna Gullledge offered to help also since she is not going to be showing a dog. Linda Miller asked about Ted Eubank judging goldens at the December show. David explained that he had already signed our contract many months ago, but was asked at the last minute to substitute for a judge at LSSC. Although not desirable, technically, it was legal since the time separating the 2 shows was over 90 days. At the Fort Worth Kennel Club meeting this month, Denise Tatro said this show would definitely be different because of all the covid restrictions.
