Meeting began at 6:30 p.m.

Lesley's first item on the agenda was a concern for the Club's facebook page. There have been postings that were inappropriate so there was a discussion whether or not it should be communication only for DFWMGRC Club members. That option was dismissed. Instead, the Board decided that Moderators should just delete inappropriate messages and then block the person posting them.

Next, Lesley presented a potential fundraising event: We could have a meeting at Pinot Palette where each person could paint their own dog on a canvas prepared for them. The Board then discussed the email from Greater Cincinnati Golden Retriever Club that Kathy Felix forwarded to the membership. Board agreed that the Club would donate \$250 to the Golden Retriever Foundation, that (per email) would be matched by GCGRC. Deadline for contribution is March 3<sup>rd</sup>.

Lesley called meeting to order at 7:02 p.m. There was a quorum present, but no vote was taken.

Lesley explained a possible fundraising event at Pinot Palette where a member could paint their own dog on a canvas where the studio had drawn their dog from a photo and marked it with areas for shading. It would cost \$75 per person but it would be a fun time and each person would leave with a nice painting of their dog. We would need at least 10 people and we could bring anything we wanted to eat. She next announced to the membership that the Board had approved a \$250 donation from the Club to the Golden Retriever Foundation which would be matched by Greater Cincinnati Golden Retriever Club. Deadline is March 3<sup>rd</sup>.

It was suggested that workers bring a cushion to sit on and even a towel to put on top of their feet.

Specialty Show Chair, Patti Caldwell, asked for a volunteer to sit ringside and write results on a whiteboard as classes come out of the ring.

Dawn gave us a little history of the Club's specialty raffle, going back to the beginning of the Club. She has been the raffle chair for about 30 years.

Patti, Dawn, and Shari were all recognized and applauded for their tenure and exceptional contributions to DFWMGRC.

Lesley asked for brags. Meeting was adjourned at 7:49 p.m.
