PROPOSED REVISION TO THE CONSTITUTION AND BY-LAWS

The Bylaws committee is proposing the following change to Article II, Section 3 of the Bylaws to coincide with the revisions made to our Membership Application. We will vote on this revision at the next membership meeting where a quorum is present.

ARTICLE II Section 3. Non Members

There shall be two classes of non-members of the Club: (a) applicants, and (b) Nonvoting members. Such non-members shall not have the privileges of membership other than to attend meetings and to receive the newsletter and other club publications.

A. Applicants are those individuals or families that apply for membership to the Club.

(1) Each applicant shall submit an application for membership via an approved Club form. The application form shall include the following provisions: (a) an agreement by the applicant to comply with Article II, Section 1 of these the Constitution and Bylaws of DFWMGRC, and (b) an endorsement of one (1) voting member in good standing or endorsement of two (2) references, preferably dogrelated, i.e., veterinarian, breeder, trainer, or the like. Accompanying the application, the prospective member shall submit an application fee for the current year as set forth in Section 4 of these Bylaws.
